



Notice of an Annual Meeting of Members

NOTICE IS HEREBY GIVEN that an Annual Meeting of the members of Multiple Sclerosis Society of Canada will be held on Saturday, June 26, 2021 at 1:00 p.m. (Eastern Daylight Time) for the following purposes:

- i. Receiving the audited financial statements for the year January 1, 2020 to December 31, 2020; together with the report of the public accountant thereon;
- ii. Electing directors to the MS Society Board of Directors;
- iii. Appointing the public accountant;
- iv. Such further and other business as may properly be brought before the meeting.

As contemplated by the bylaws of the Society, the directors have determined that the meeting will be held entirely by electronic means; by videoconference and telephone.

On June 4, 2021, the audited financial statements will be made available on our website www.mssociety.ca/about-us/governance or by calling 647-956-0299 to request a copy be mailed to you.

The constating documents of the Society provide that the Society shall have a Board of Directors consisting of a minimum of 12 and a maximum of 17 members, and the Board is empowered to fix the number of directors within that range. The number of directors is currently at 15. The term of office of two of the current directors will expire at the upcoming annual general meeting. Any member wishing to nominate a candidate as a director will be required to provide biographical information about the said nominee before Friday, June 4, 2021 at 4:00 pm Eastern Daylight Time. Biographies of candidates standing for election will be made available on www.mssociety.ca/about-us/governance by or on June 4, 2021.

Pursuant to the bylaws of the Society, there is one class of Members of the Society. Membership in the Society is available to individuals who wish to further the purposes of the Society and is administered by the Divisions and Chapters in accordance with the Membership Policy. Members attending the AGM will be confirmed in good standing in keeping with the governance rules and regulations of the Society. A Member will be considered to be in good standing if the Member was admitted to membership at least ninety (90) days before the AGM. Existing Members may renew their membership immediately before the AGM if their membership has not been lapsed for more than one year.

Members will join the meeting virtually, either by videoconference or phone. Please pre-register by June 4, 2021 for the Annual General Meeting by emailing membership@mssociety.ca or calling 647-956-0299. Information regarding access to the meeting will be forwarded upon registration.
